Food Distribution In 2024, we distributed food to 189 families, including 31 parents, 38 youths, and 120 children from 0 to 15 years. Food distribution helps low-income households and individuals with food security. It prevents hunger and improves the health of low-income children, infants, new mothers, pregnant women, and the elderly by supplementing their diets with these free donated foods. We receive this donated food from the California Emergency Food Link and have a contract with them. We distribute these foods to the following two addresses: 650 El Camino Ave, Sacramento, CA 95815 and 2721 Fulton Ave, Sacramento, CA 95821

Job Placement Program We have referral systems with the Loa family, Sacramento Youth Center, Sacramento Works Job Center, and Public Health Institute (PHI). We have sent our clients to their programs for job placement

Cultural Orientation: Cultural and social activities are super important for students' overall growth. Taking part in these activities improves how students talk to each other, work in teams, and build friendships, preparing them for future challenges. Additionally, participation in cultural activities can improve the academic performance of students. It also helps in students' physical, behavioral, and social development. So, we provided cultural orientations to 120 individuals at our office : 2172 Rassy Way, Sacramento, CA 95821

Mental Health Program The program aims to assess the mental health needs of the Sacramento Afghan community and engage community members in activities that decrease the negative impact of their daily stressors. Potential stressors include housing insecurity, difficulties meeting basic needs, uncertainties regarding immigration status, employment and education challenges, language and cultural barriers, loss of social and economic status, and discrimination. In this program, we provided psychosocial counseling and social services to 80 newly arrived Afghans and then we referred them to related organizations

Outreach Program: Our outreach program mainly focuses on newly arrived Afghans who have multiple issues. We connect them with resources, help them navigate complicated systems, and support them in accessing education, employment, and healthcare. We also work to ensure our services are culturally appropriate and trauma-informed. Self-sufficiency is essential; we provide information, practical steps, and guidance toward their success. We provided outreach services to 240 individuals in the following zip codes: 95660, 95811, 95815, 95821, 95823, 95825 and 95828
